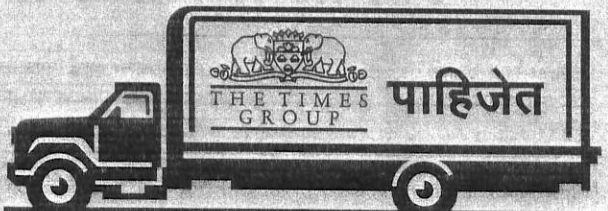

SU Selloffs 's Listing likely by Q4'

Listing of Life Insurance Corporation of India, which is the largest for Indian companies in the fourth quarter of the financial year, is expected to be announced by investment and public relations secretary TK Pandey on Wednesday.

The ongoing strategy of Bharat Petroleum Limited and other companies is likely to conclude by the end of the year.

The largest issue in our portfolio, he said, is to answer a question from MD Arun Mehra in the last quarter about the financial year.

He expects LIC's initial offering to fetch around Rs 1,000 crore in a strategic sale of shares worth Rs 75,000 crore.

The privatisation of public sector companies under the Economic Sector Enterprise Act, 2008, is a government will to move away from non-strategic sectors. He said that the private sector is expected to participate in the process.

to see some privatization, it's a message to all the stakeholders," he said.

"As much as the government would like to disinvest, we also need businesses to come forward and participate in our bidding processes. Essentially, we have to really create a market for public assets and the market is well created when there is a transparency, competitive bidding," he added.

While responding to a question on disinvestment of Air India, Pandey said that while the sale was delayed by two years, it was in the direction of government moving out of businesses that were not doing well under government control.

"We had a turnaround plan in Air India, we didn't succeed in the public sector. So let's admit it and let us really hope that somebody could be able to put it together something... take it over and carry on and let the employment be safe," he said.

Lok Sabha Passes IBC Amendment Bill

New Delhi: The Lok Sabha has passed the Insolvency and Bankruptcy (amendment) bill, which paves the way for a pre-packaged resolution process for the Micro, Medium and Small Enterprises sector.

Minister of State for Corporate Affairs Rao Inderjit Singh moved the bill for consideration and passage amid din in the lower house of Parliament, which was later passed without any discussion with opposition members continuing their protest over Pegasus snooping issue and the three new farm laws.

Singh said the Insolvency and Bankruptcy Code (Amendment) Bill, 2021, will replace the ordinance that was promulgated on April 4 as part of efforts to provide relief to MSMEs adversely impacted by the pandemic.

The bill proposes a new chapter in the IB Code to facilitate the pre-packaged insolvency resolution process for corporate persons that MSMEs.

As per the Statement of Objects and Reasons of the bill, it seeks to specify a minimum threshold of not more than Rs 1 crore for initiating the pre-packaged insolvency resolution process as well as provisions for disposal of simultaneous applications for initiation of the insolvency resolu-

tion process and pre-packaged insolvency resolution process, pending against the same corporate debtor.

The proposed amendments would enable the government to notify the threshold of a default not exceeding ₹1 crore for initiation of the pre-packaged resolution process. The government has already prescribed the threshold of ₹10 lakh for this purpose.

There would be a penalty for fraudulent or malicious initiation of the pre-packaged insolvency resolution process, or with intent to defraud persons, and for fraudulent management of the corporate debtor during the process.
